University of Pennsylvania Alumni in California City Management

In 1749, **Benjamin Franklin** — printer, inventor and future founding father of the United States — published his famous essay, "Proposals Relating to the Education of Youth," and circulated it among Philadelphia's leading citizens. He organized 24 trustees to form an institution of higher education. Led by **Ben Franklin**, they purchased the property for and educational institution and assumed the responsibility of its trust. In 1751, the University of Pennsylvania opened its doors to the children of the gentry and common people alike as the "Academy and Charitable School in the Province of Pennsylvania."

Commonly referred to as "Penn" or "UPenn," the University of Pennsylvania is the fourth-oldest institution of higher education in the U.S. This private university, located in Philadelphia, the first U.S. university to offer both undergraduate and graduate studies.

Founded in 1937, the **Fels Institute of Government** is the University of Pennsylvania's graduate program in public policy and public administration. It is one of the most personal and practical program in public management in the Ivy League. The program practices what it teaches through Fels Research & Consulting, which brings together **proven leaders in the public sector with top students** to develop innovative solutions to the community's most challenging issues. Here are some Penn California city management community folks:

Allan R. Schell of Merced began his public service career in 1954 as an Administrative Assistant in Oak Park, Illinois. In 1956 Allan moved to California and became the Assistant to the City Manager in Hayward. He was appointed La Verne City Manager in 1959 and moved north to be the Roseville City Manager in 1962. Allan moved to the Merced City Manager post in 1968 and served there until 1983. Since then he has worked in the private sector. Allan earned a BA from Drake University and an MGA from the University of Pennsylvania. Allan was a 1971 recipient of the ICMA Management Innovation Award, and in 1979 he received a 20-year ICMA Service Award.

Dave Kiff became the Newport Beach City Manager in September, 2009 after joining the city staff in 1998 as the Assistant to the City Manager. Dave was elevated to Deputy City Manager and Assistant City Manager before being selected for the City Manager post. Prior to coming to Newport Beach Dave worked as an Assistant to the City Manager in Orange. He served as an assistant on the staff of Orange County Supervisor Marian Bergeson, and as a staff consultant to the Senate Local Government Committee in the California Legislature before moving to local government. He earned a BA at California State University, Sacramento, and an MGA from the Fels Institute at the University of Pennsylvania. Dave is a four-time Ironman triathlete.

In 1965 **Donald A. Blubaugh** became an Assistant to the City Manager in Riverside. In 1969 Don moved to the Assistant City Manager position in Palm Springs, where he served until 1973 when he was appointed Palm Springs City Manager. Don moved north in 1979 to become the Hayward City Manager, and in 1988 he took the City Manager post in Walnut Creek where he served until 2002. Between 2002 and 2007 Don served as President of Public Service Search Skills, Inc., and during that time he served as Interim City Manager in Orinda (2005), Oakley the same year (2005), and Martinez (2006-2007). Don was appointed Martinez City Manager in 2007 and served for about a year before he again retired. Don served as an ICMA Range Rider between 2002 and 2007. He is a past President of the City Managers' Department of the League of California Cities (1990-1991). He participated in the ICMA Exchange Program to the United Kingdom. Don earned a BA from Shippensburg State University and an MGA from the Fels Institute for Local and State Government at the University of Pennsylvania. He received a 35-year ICMA Service Award in 2000.

He left there in 1968 to take a similar post in Claremont, and in 1969 he was chose to serve as the Claremont Deputy City Manager. In 1974 Norm took the Assistant Director, Policy Analysis position with the National League of Cities in Washington, D.C. He returned to Claremont in 1975 when he was selected to serve as City Manager. Norm was appointed City Manager in Palm Springs in 1979, and he served there until 1990. In 1991 Norm became Moreno Valley City Manager, and in 1996 he was appointed Executive Director of the San Bernardino Associated Governments-Transportation Commission. He served SANBAG until 2005, and in 2006 Norm took the post of Director of the Leonard Transportation Center at California State University, San Bernardino. A whole generation of baby-boomer managers has or will soon retire. Because this has been a "quiet crisis," the professional associations have not responded with substantive support for senior managers who are struggling with how to successfully transition to their next life phase and develop fulfilling "encore" chapters. The Cal-ICMA Board has authorized the development of a Senior Manager/Encore Manager Initiative and created a committee to guide the effort. Home Rule Problem:

Typical State Capitol thinking: Governor **Jerry Brown's** press secretary **Gil Duran** explains that SB 89, walked onto the floor at the last minute in the late evening hours of June 28, 2011, without committee review, according to the League of California Cities, "...don't demand cuts and then complain about cuts." SB 89 takes away Motor Vehicle License Fee revenue from new California cities. It took \$6.7 million, nearly 46%, of the Jurupa Valley operating budget overnight. Jurupa Valley City Manager **Steve Harding** said that the city was two days from opening the doors to the new city hall when they got a late-night call about the State action (to dip into the pockets of local government). Other new cities that lost funding include: Eastvale, \$2.9 million; Menifee, \$3.6 million, and Wildomar, \$1.7 million. Efforts are in the works to fix this revenue shift that was never review by Legislative Committee. "Will this State, or any other State, be willing to see cities become insolvent by State action?" asks City Manager **Steve Harding**. He is supporting SB 1566 which will reverse the budget-killing SB 89 and reinstate most provisions of AB 1602.

No Meal Time Policing:

State law does not compel an employer to ensure employees cease all work during meal periods. While employers are required to free workers of job duties for a 30-minute meal break, the employee is at liberty to use the time as they choose even if it is to work. An employer is not obligated to police meal breaks and ensure no work thereafter is performed, said Associate Justice **Kathryn Werdegarr** in a California Supreme Court decision in a case file against the parent company of Chili's restaurants.
