**Tule Lake** was a center for Japanese American resistance to incarceration during World War II, where thousands of Japanese Americans herded into concentration camps. Tule Lake was the largest and most controversial of the ten War Relocation Authority WRA camps used to carry out the government's system of exclusion and detention of persons of Japanese descent, mandated by Executive Order 9066. The Order, which eliminated the constitutional protections of due process and violated the Bill of Rights, was issued February 19, 1942 following Japan's attack on Pearl Harbor on December 7, 1941. Two-thirds of the 120,000 persons of Japanese descent incarcerated in American concentration camps were American citizens. Tule Lake opened May 26, 1942, detaining persons of Japanese descent removed from western Washington, Oregon and Northern California. With a peak population of 18,700, Tule Lake was the largest of the camps - the only one turned into a high-security segregation center, ruled under martial law and occupied by the Army. Due to turmoil and strife, Tule Lake was the last to close, on March 28, 1946.

Tehama is a City in Tehama County in the Red Bluff area with a population of about 418, according to the 2010 census. "Tehama" is believed to be an Indian work, but authorities disagree on the meaning. The various meanings have been reported as: "high water," "low land," "salmon," or "shallow." A Nomlaki village once stood on the site of modern-day Tehama on the back of the Sacramento River.

<u>Trinity County</u> does not have any incorporated cities. According to the 2020 census numbers, Trinity County has a population of 13,786. Weaverville, who has some of California's oldest buildings, is the county seat. The Weaverville Courthouse was built in 1856. Trinity County, an original California county upon Statehood, takes its name from the Trinity River

La Habra Assistant City Manager Jennifer Cervantez, 39, has been appointed to replace retiring Rancho Santa Margarita City Manager Steve Hayman, 59. Jennifer is the 3rd city manager in Rancho Santa Margarita since its incorporation in 2000. She previously worked for Santa Ana and the League of California Cities, previous to her La Habra post.

Handicap parking violations, parking in a bus zone, and registration/tab violations, and the like are still frequently issued on a parking ticket/citation form. Each individual jurisdiction of issuance establishes the amount of the bail/fine based on the applicable Municipal Code or the California Vehicle Code (CVC), and the amount agreed upon by the issuing iurisdiction. A portion of each fully ticket/citation goes to the State. The State now gets \$12.50 (surcharge for courthouse and reconstruction) for every fully paid parking citation. Tell your family members and friends to never ever park in a handicapped zone or bus zone. Those are "big ticket" fines! Cities, counties and the initial review and/or hearing officers that receives the contesting documents, or in-person hearings, have NO mercy when it comes to asking for a dismissal on these violations.
